The Company would like to announce that it and/or its related corporation(s) has/have repurchased S\$29,500,000 in aggregate principal amount of the Notes (the "**Repurchased Notes**") in the open market.

The Repurchased Notes have been cancelled on 20 April 2016 in accordance with the terms and conditions of the Notes. Following the cancellation of the Repurchased Notes, the aggregate outstanding principal amount of the Notes is S\$95,500,000.
